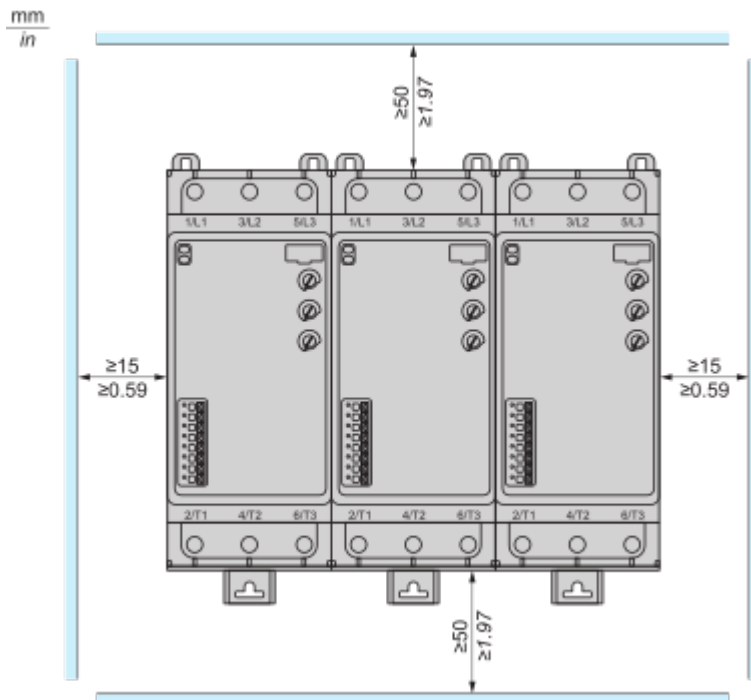

ATS130 Standalone

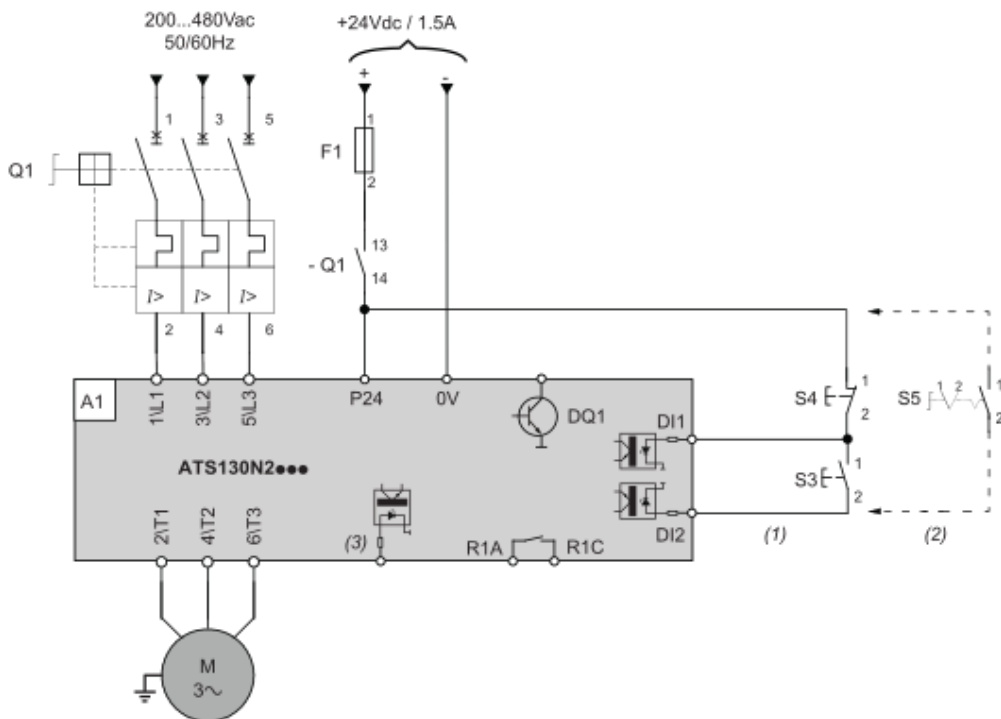


ATS130 Side by side

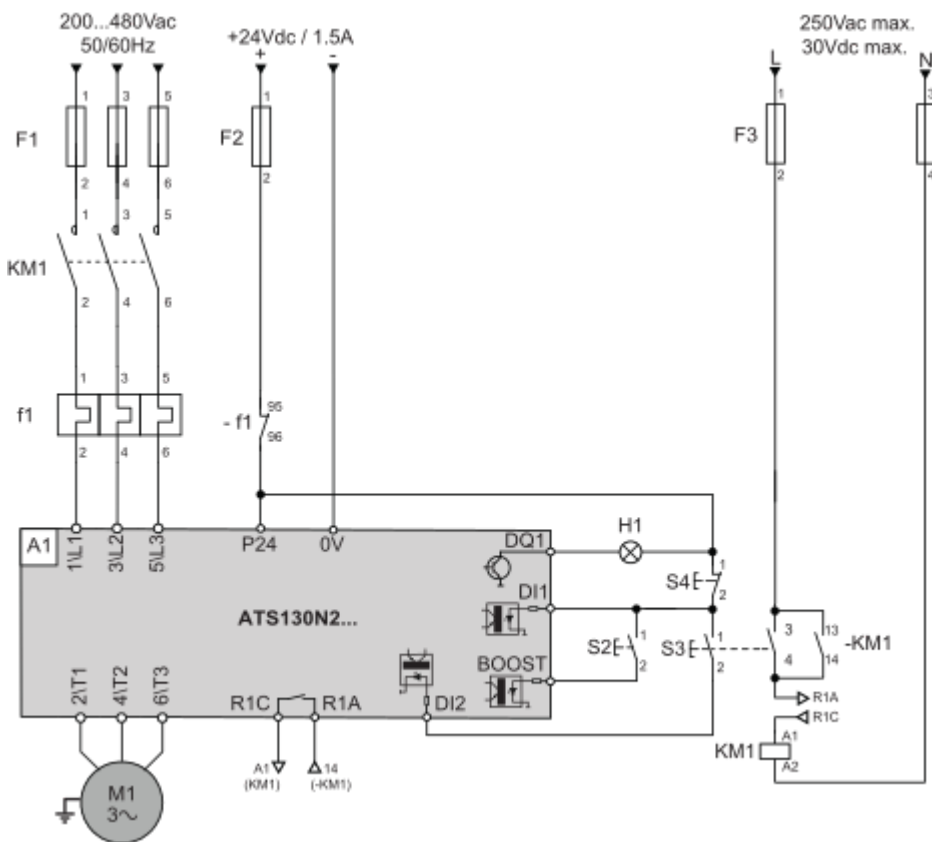
